### **Revised Edexcel Level 3, 4 & 5 NVQs in Learning and Development**

I am writing to let you know about the arrangements for existing centres to offer the revised Edexcel NVQ qualifications within **Learning and Development**. This applies to all new learners registering on programmes from **1 August 2002**. This pack should be read fully before completing the enclosed application forms.

The published guidance and log books, detailed below, will replace all previous Edexcel guidance and log-books and programmes currently approved by Edexcel in this area. A transition map showing the new qualification titles and the appropriate current titles being replaced is included with this letter.

The new qualification titles are also listed in the transition map and within the approval forms attached.
